FILING FEE

■ **Have you enclosed the £10 filing fee?**

- Cheques must be made payable to 'Companies House'.
- You can also pay by credit card or cash. For credit card payments, send a covering letter with your application, providing a telephone number for us to contact you to arrange payment.
- If the £10 fee has been paid previously, cheque details will be needed in order to transfer the fee payment - cheque number, sort code, account number and date of payment.
